Pursuant to A.R.S. § 38-431.02, notice is hereby given to the public and members of the Arizona State Board of Nursing (“Board”), that the Board will hold a meeting open to the public at the address listed above. The Board Virtual Access to Meetings: Board members may attend board meetings via video conferencing or in person. Meeting will continue each day until all business is completed. If the meeting time is beyond 5:00 p.m., the Lobby Security Officer or staff will allow public access through the public entrance.

Persons associated with matters listed on the agenda may appear in person or by telephone if arranged in advance with Board staff. Members of the public may attend the meeting in person at the above address. Board meeting room capacity is limited. If maximum capacity is reached, we may ask attendees to attend the meeting in a nearby overflow conference room with video and audio access. Alternatively, persons may also listen to the meeting online, with live streaming audio, available at the Board’s website: www.azbn.gov.

The Board may discuss and decide on any matter listed on the agenda.

Those wishing to address the Board are asked to fill out a speaker slip at the kiosk and attend in person unless telephonic attendance was arranged in advance (for persons associated with matters listed on the agenda). The Board may require groups who wish to make similar statements to the Board to choose one representative to speak on behalf of the group.

While persons addressing the Board may raise any relevant/appropriate topic, pursuant to A.R.S. § 38-431.02(H), the Board may only take action on matters listed on the agenda. If a matter is not listed on the agenda, the Board may direct Board staff to study it or schedule it for discussion at a future public meeting, if appropriate.

The agenda is posted on the Board’s website and is subject to change up to 24 hours before the meeting. Please check the Board’s website for any changes. The Board may address the agenda items in any order within the time frame shown and may continue matters at a future meeting when necessary. The Board may change the order of items on the agenda, except that matters set for a specific time must be called on or after the time and date listed on the agenda.

The board may accept, reject, or modify any recommendation listed on the agenda. Only a majority vote makes the decision final.

In addition, for any matter listed on the agenda, if the Board makes a finding that public health, safety and welfare imperatively require emergency action, the Board may summarily suspend the license, certificate, or approval pending proceedings for revocation or other action, which shall be promptly instituted and determined. A.R.S. § 41-1092.11(B).

When necessary, upon a majority vote of a quorum of the members, the Board may hold an Executive Session to get legal advice regarding any of the agenda items, pursuant to A.R.S. § 38-431.03(A)(3); or may hold an Executive Session on agenda items II - VII to review confidential records exempt by law from public inspection, pursuant to A.R.S. § 38-431.03(A)(2). Other executive sessions also may be listed on the agenda.
