Within the Scope of Practice of: RN LPN

ADVISORY OPINION INTRAUTERINE/INTRACERVICAL INSEMINATION

It is within the Scope of Practice for a Registered Nurse (RN) to perform intrauterine/intracervical inseminations if the following requirements are met:

I. GENERAL REQUIREMENTS

- A. The decision to perform the intrauterine/intracervical insemination has been initiated by a Licensed Independent Provider (LIP)/Physician Assistant.
- B. Written policy and procedures are maintained by the employer/agency.
- C. Only RN's who have completed an agency's instructional program and have had supervised clinical practice are allowed to perform intrauterine/intracervical inseminations.
- D. Documentation demonstrating competence in intrauterine/intracervical insemination is on file with the employer.
- E. Informed consent obtained by an RN performing the procedure.

II. COURSE OF INSTRUCTION is to include, but not limited to:

- A. Anatomy and physiology of the pelvis, perineum and reproductive system
- B. Indications and contraindications for the procedure(s)
- C. Informed consent
- D. Proper patient and sperm preparation identification
- E. Potential side effects and complications
- F. Vaginal speculum exam and intrauterine/intracervical insemination procedures
- G. Nursing care responsibilities

III. RATIONALE

To provide guidelines consistent with current practice in outpatient clinics providing fertility enhancing services.
