Consistent with the RHTP provisions of H.R. 1 at section 71401, Arizona will be proposing a plan to the Centers for Medicare & Medicaid Services (CMS), seeking funds to improve healthcare access and quality of care in rural Arizona. The State of Arizona is requesting information in the form of stakeholder input regarding possible uses of Rural Health Transformation Program (RHTP) monies in Arizona, with an emphasis on mitigating impacts from H.R. 1 to healthcare in Arizona, including likely growth in uncompensated care.
