### **RE: CEASE AND DESIST LETTER**

Dear SANDRA J MILLER:

The Board of Nursing has received information that you have been representing yourself as a nurse to healthcare professionals (Hospice of the Valley) and other members of the public. There is no record at the Board which validates you hold a license to practice nursing in Arizona and as you are aware in May 1997 you entered into a Consent Agreement for Voluntary Revocation and your license, LP006922.

Pursuant to A.R.S. § 32-1666(A)(1)(3): It is unlawful for a person who is not licensed or certified under this chapter to: (1) Practice or offer to practice professional or practical nursing in this state. (3). Represent or use any title, abbreviation, letters, sign, card or device to indicate that the person or any other person is a licensed practical nurse or a certified nursing assistant.

Pursuant to A.R.S. § 32-1641: Only a person who holds a valid and current license to practice as a licensed practical nurse in this state or in a party state as defined in A.R.S. 32-1668 may use the title "nurse", "licensed practical nurse", "practical nurse" or the abbreviation "L.P.N."

Pursuant to A.R.S. § 32-1606 (A) (4) The Board may refer criminal violations of this chapter to the appropriate law enforcement agency.

Pursuant to A.R.S. § 32-1667(2): A person is guilty of a class 6 felony who: (2) Engages in any conduct prohibited in section 32-1666.

The Arizona Board of Nursing demands that you immediately cease and desist implying to the public of Arizona that you are a nurse.

Be advised that the Board will turn your case over to the appropriate law enforcement agency and proceed with criminal action in a court of law.
