CONSENT AGREEMENT

Pursuant to a request from Navajo Technical University Nursing Assistant Program ("Respondent"), the Arizona State Board of Nursing ("Board") and Respondent hereby agree to amend Consent Agreement Order No. 22034NA1090 ("Order"). Respondent understands and agrees that, other than the specific modifications contained in this FIRST Amended Consent Agreement and Order No 22034NA1090 ("First Amended"), all other terms and conditions of Order No. 22034NA1090 remain in effect.

On March 22, 2024, the Board voted to amend Consent Agreement Order No. 22034NA1090, Respondent agrees to issuance of this First Amended to the Order and waives any and all rights to a hearing, rehearing, appeal or judicial review relating to these matters. Respondent further waives any and all claims or causes of action, whether known or unknown, that Respondent may have against the State of Arizona, the Board, its members, officers, employees and/or agents arising out of this matter.

Respondent understands that all investigative materials prepared or received by the Board concerning these violations and all notices and pleadings relating thereto may be retained in the Board's file concerning these matters.

Respondent understands the right to consult legal counsel prior to entering into this First Amended and such consultation has either been obtained or is waived.

Respondent understands that this First Amended is effective upon its acceptance by the Board

and by Respondent as evidenced by the respective signatures thereto. Respondent's signature obtained via facsimile shall have the same effect as an original signature. Once signed by Respondent, the Agreement cannot be withdrawn without the Board's approval or by stipulation between Respondent and the Board's designee. The effective date of this Order is the date the First Amended is signed by the Board and by Respondent. If the Amended is signed on different dates, the later date is the effective date.

Respondent acknowledges and agrees that the acceptance of this Amended is solely to settle these Board matters and does not preclude the Board from instituting other proceedings as may be appropriate now or in the future.

Furthermore, and notwithstanding any language in this Amended, this Amended does not preclude in any way any other state agency or officer or political subdivision of this state from instituting proceedings, investigating claims, or taking legal action as may be appropriate now or in the future relating to this matter or other matters concerning Respondent, including but not limited to, violations of Arizona's Consumer Fraud Act. Respondent acknowledges that, other than with respect to the Board, this Amended makes no representations, implied or otherwise, about the views or intended actions of any other state agency or officer or political subdivision of the state relating to this matter or other matters concerning Respondent.

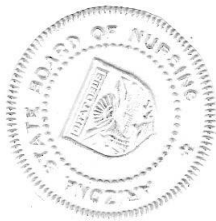
